TERMS OF AGREEMENT

1. Terms of Reference

For the purpose of this Agreement, the term "the Organizer" shall mean Jade Apple Marketing Pte Ltd. The term "Delegate" shall mean any company or its employees who has/have signed for the conference.

2. Application for Conference

The submission of the registration form shall be deemed acceptance of the Terms of Agreement by the Delegate. The application procedure is complete only when the registration form and full payment are received by the Organizer. The Organizer shall reserve the right to refuse any application without giving any reason.

3. Cancellation

- a. Cancellation is not allowed after signing of the registration form. Delegate shall pay the cancellation fee equal to the registration fee. All cancellation fees are payable immediately upon cancellation. All payments made to Organizer under this contract are deemed fully earned and non-refundable and made in consideration for expenses incurred by the Organizer and Organizer's lost or deferred opportunity to provide a conference seat to others, and all cancellation fees that may become due hereunder are acknowledged by Delegate to constitute liquidated damages.
- b. Delegate shall be responsible for payment to Organizer for all amounts which would have been due to the Organizer under the terms of subsection (a) above. All other provisions of this contract will continue in force until cancelled by Organizer.

4. Change of Dates and Venue

The Organizer reserves the right to change the date and venue of the Conference should circumstances so require. The Contract shall remain effective for the new date and venue provided the notice of change is made to the Delegate one to two weeks before the changes.

5. Force Majeure

The Organizer shall not be liable for any delay or failure to perform its obligations under this Contract caused by circumstances beyond the control and without the fault or negligence of the Organizer including war (declared or undeclared), natural disaster, riot, civil commotion, acts of God, fire, blockades, labor disturbances, strikes, insurrections, earthquakes, acts of terrorism and matters beyond the Organizer's reasonable control.

6. Insurance, Liability and Risks

The Delegate shall insure, indemnify and hold the Organizer and the venue managers harmless in respect of all costs, claims, demands and expenses for incidents incurred by the Organizer and its staff upon any person or things at the event venue.

7. Venue and Venue Property

The Delegate shall take all necessary precautions to prevent any harm done to the venue and venue property. The Delegate is liable to compensate the Organizer for any damage done to the venue or venue property.

8. Refusal of Admission

The Organizer shall reserve the right to refuse any person admission to the Conference Venue or in the general interest of the Conference.

9. Supplementary Clauses

The Organizer shall reserve the right to issue verbal Supplementary Regulations in addition to those in the TERMS OF AGREEMENT to ensure the orderly management of the Conference. Any supplementary Regulations shall form parts of the TERMS OF AGREEMENT and they shall be binding on all Delegates.

10. Breach of Agreement

In cases where the Delegate fails to observe and perform any of the terms of this Agreement or any Supplementary Regulations stipulated in Clause 9 above, the Organizer shall reserve the right to terminate the Agreement and all fees paid by the Delegate to the Organizer will be forfeited. Delegate shall furthermore indemnify the Organizer for all losses and damages resulting from such failure in observing or performing the terms of this Agreement.

11. Interpretation

Interpretation of this Contract lies solely with the Organizer. This Contract shall be governed by and construed according to Singapore law.
